## ► ABOUT US

Universitas Gadjah Mada is the oldest university in Indonesia which was founded in 1949 where the development of the national education has been treated in the university to produce many experts in many disciplines. The university has eighteen faculties and there are approximately fifty-six thousand students pursuing degrees for undergraduate, graduate and postgraduate in the university.

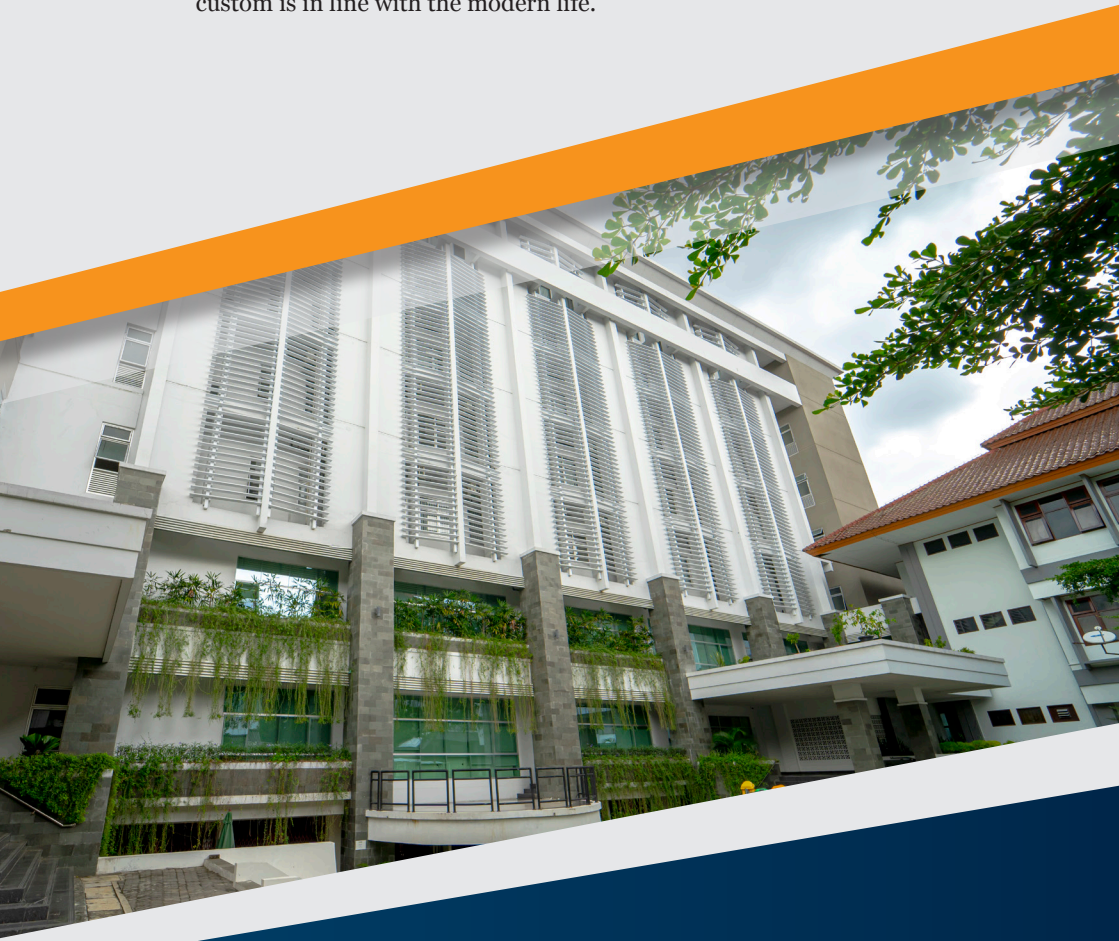
Faculty of law as one of the excellent faculties among the eighteen faculties in the university has taken a big role in supporting the mission of the university “to become a world class research university” by establishing International Undergraduate Program (IUP).

In the IUP, lectures are taught in English that enables students from around the world to study in this faculty and also learn the local wisdom. Not only that, it surely develops the local students for their English as international legal experts are highly demanded in globalization era nowadays. The program requires 146 credits of courses, including fieldwork or internship and thesis. The standard duration for the program is 4 years comprising 8 semesters. The program focuses on developing critical thinking and gives student knowledge and skill to understand and implement various aspects of law and regulations with International Perspective. Students graduated from this program are awarded with a degree of *Sarjana Hukum* (Bachelor of Laws).



## ► LOCATION

Universitas Gadjah Mada is located in Yogyakarta province where Javanese culture has developed for hundreds of years. Visitors to Yogyakarta see this city as a cultural city in many ways. Art festivals including traditional music (*gamelan*), batik festival, and play performance are lively performed in the midst of modernity. It is no wonder that Yogyakarta is well known as a city where traditional custom is in line with the modern life.

## ► LINKAGE

As an international program, networking with overseas universities has been made into Memorandum of Understanding by the Management. It has been years that IUP has collaborated not only with universities in United States but also in Europe, in Australia and in Asia as well.

Furthermore, the IUP has been working together with the Board of Partnership (BoP) for the other cooperation whose members are legal practitioners from government, private sector and prominent law firms, who are concerned with the developments of IUP. This BoP will give practical experience towards the students in their internship period.

With those linkages, students in the IUP have opportunity to get international experiences studying abroad and also practical experience in professional world.



## ► DUAL DEGREE

One of the most significant advantages of being admitted as a student at IUP FH UGM is the availability of a dual degree opportunity. This means the exceptional IUP students have the chance to obtain two undergraduate degrees in law, one from UGM and one from a partner university abroad, without having to spend three to four extra years. In approximately four years successful candidates will have obtained a *Sarjana Hukum* degree from UGM and a *Legum Baccalaureus* (Bachelor of Laws/LL.B.) from a partner university.

The Faculty continuously make negotiation with more prospective partners for a dual undergraduate scheme, but at the present there are two universities students can choose to pursue a second degree:

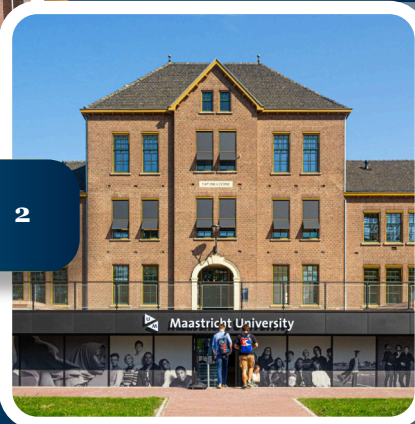

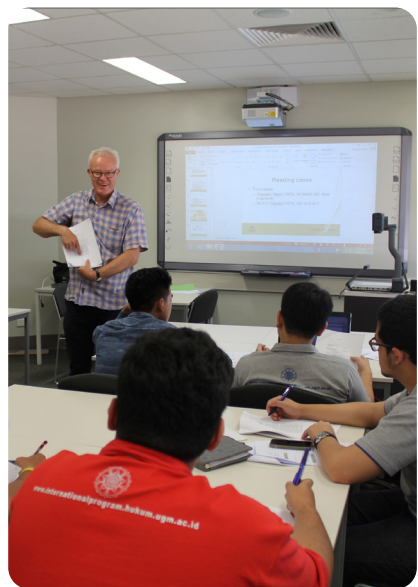




## ► INTERNSHIP

The internship program at the IUP is mandatory. Within the current curricula, students have to undertake two internships. Students can choose to do their internships at our various partners, which ranges from law firms, government institutions, corporations, and NGOs.

The Program aims of opportunities for students to gain insight into a work place. By participating in this Program, the students' skills and educational experience can be enhanced through practical work assignments.





## ► SUPPORTING FACILITY

## ► **ADMISSION REQUIREMENTS**

In order to be considered for admission into the International Undergraduate Program a candidate must:

1. Indonesian Senior High School (SMA) or the equivalent graduate with good academic records.
2. Hold A-Level qualification, IB qualification, or equal to Indonesian High School qualification.
3. Pass AcEPT (Academic English Proficiency Test).
4. Pass GMST (Gadjah Mada Scholastic Test).
5. Pass FGD (Focus Group Discussion) & Interview Test.

### **TUITION FEE**

- Tuition Fee Per Semester for Indonesian Students is IDR 30,000,000.-
- Tuition Fee Per Semester for Non Indonesian Students is IDR 40,000,000.-
